Criteria for Nominations:

- Nominees must be Hispanic and may be from the public or private sector in the areas of arts, business, civic involvement, education, public service/government, and media. The “Orgullo” Award is given to a non-Hispanic person or organization whose contributions have enhanced the Hispanic community.

Nominees must have achieved outstanding success in their chosen fields, whether it is a traditional career or an active career of volunteer service.

- Nominees must have resided in the Tampa Bay area for at least three years.
- Current Board members, former Board members within the last two years, past recipients, and sponsors are not eligible for nominations.

Judging:

The Hispanic Leadership Class of 2008 committee is comprised of a panel of judges who embody high standards of integrity and community service. The judges’ decisions will be announced on October 1st, 2008. The awards will be presented at a cocktail reception on Friday October 24, 2008, at the Intercontinental Tampa Hotel, located at 4860 W. Kennedy Blvd. Tampa, FL 33609.
